

# The 47th Japan Cooperation Forum for the Middle East in Vienna: 'Japan's Business Strategy in an Increasingly Complex Middle East' Held

Sept 6, 2024 JCCME

JCCME hosted the 47th Japan Cooperation Forum for the Middle East in Vienna on August 22 and 23, 2024, with the support of the Ministry of Economy, Trade and Industry (METI).

This historic event, held since 1976, aims to establish multilayered and sustainable relationships between Middle Eastern countries and Japanese enterprises, fostering a deep understanding of the local situation and focusing on a long-term business environment. This year's forum, themed "Japan's Business Strategy in an Increasingly Complex Middle East", attracted over 220 participants, including representatives from the METI, the Ministry of Foreign Affairs, Japanese firms, Middle East experts from both within and outside Japan. The attendees engaged in active discussions on the theme. (For the details of the program, please refer to pages 3 to 5.)

Reflecting on the geopolitical landscape in the Middle East, the Abraham Accords of September 2020 played a significant role in normalizing diplomatic relations between Israel and Arab nations such as the UAE. In early 2021, the diplomatic relations were restored between Qatar and each of Saudi Arabia, UAE, Bahrain, and Egypt after a rift of about three and a half years. In early 2023, Saudi Arabia and Iran also re-established their diplomatic ties. However, the Hamas-Israel intensifying conflict since October 2023 halted the momentum of these diplomatic efforts, plunging the region back into chaos. The Gaza War has also given negative economic impacts. Attacks on vessels in the Red Sea have disrupted international trades, dramatically reducing the number of ships passing through the Suez Canal and the volume of cargo handled at ports along the Red Sea coast. These events have highlighted the vulnerability of global supply chains.

All the speakers at this forum provided comprehensive analyses on politics, economy, and security, which were critical for Japanese companies in developing business strategies for the Middle East during times of uncertainty. They also shared their insights on political measures taken by the US, China, South Korea, India, and other countries.

In closing, a panel discussion titled "Changes in Arabic and Iranian Diplomatic Strategies Towards Israel and Business Strategies of Japanese Companies" was held. The panelists examined the impact of the Gaza War on various sectors, shared their views on the current geopolitical landscape, provided forecasts for the impact of 2024 U.S. presidential election results, and discussed emerging trends, events, and changes from multiple perspectives.

This forum was a valuable opportunity to explore how Japanese enterprises should navigate the intensifying uncertainty and to gain knowledge and insights for building mutually beneficial relationships between Middle Eastern countries and Japan. Meanwhile, all onsite attendees participated in a separated networking session. This confirmed that participants at the forum strongly preferred in-person communication. The morning sessions, added to the program for the first time, attracted many participants and were highly appreciated by the attendees as excellent opportunities for exchanging in-depth comments.

JCCME will continue to strive towards our goal of being a robust hub between the Middle East and Japan, as well as public and private sectors, based on the outcomes of discussions and surveys conducted in this forum.
